- The institutions shall ensure the fulfillment of the following :-4.
 - The institutions shall maintain the teaching staff strength of 1+7 for the sanctioned B.Ed. (a) course and all the appointments would be on regular basis on an approved scale of payment of the candidates having fulfilled eligibility condition prescribed by NCTE. The institute concerned shall send a report in this regard to WRC of NCTE within 30 days, in terms of clause 7 (12) of the NCTE Regulations 2005.

The institutions shall note that with regard to NET / SLET requirement, the relaxation is (b) allowed only upto the year 2009-2010 as per NCTE Regulation dt. 21.7.2006.

The institutions shall adhere to all the other regulations and guidelines as framed by NCTE (c) from time to time.

The institutions shall within one month of the receipt of the Recognition order, convert (d) the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five Years) in a Nationalized Bank only to be operated along with an authorized official of the Regional Committee.

That the Reserve fund for an amount of Rs. Three Lakhs be maintained in the form of FDR (e) in favour of the managements / institutions.

Further, the recognition is subject to fulfillment of all such other requirements as may be (f) prescribed by other regulatory bodies like UGC and State Government etc.

The institutions shall submit to the Regional Committee a Self Appraisal Report at the end (g) of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.

The institutions shall regularly update their website. (h)

The institutions intending to run the teachers training programme approved above in a rented premises are required to submit report in compliance of the requirement of NCTE (i) Regulations on the subject regarding their shift to permanent building.

- If any of the institutions contravene any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and / or order made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act 1993. The NCTE Hqrs. May also cause inspections under Section 13 of NCTE Act, 1993.
- It is mandatory for the institutions to complete 180 teaching days as such the concerned university/board should ensure the recognition granted as per NCTE regulations and if the recognition date did not match with the academic calendar then the recognition granted shall be effective from the ensuing academic session. RESTORATION ORDER

Whereas, recognition was granted to the institution, I. D. College of Education, I. D. Patel Education Campus, (run by Matrukrupa Education & Charitable Trust), opp. Nirman Tower, Near Vishvas City, Ghatlodia, Ahmedabad, Gujarat – 380061 under section 14 of NCTE Act, 1993 for conducting B.ED.course with an annual intake of 100 students vide order no. WRC/5-6/50/2006/C-11609 dt.02.03.2007 & WRC/APW02623/323308/154th/2011/82757-82762 dt.04.11.2011.

- 2. And whereas, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014, I. D. College of Education, I. D. Patel Education Campus, (run by Matrukrupa Education & Charitable Trust), opp. Nirman Tower, Near Vishvas City, Ghallodia, Ahmedabad, Gujarat 380061 offering B.Ed. course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014 by the institution.
- 3. And whereas, after the receipt of affidavit dt. . 28.03.2015 from the institution, a revised recognition order no. WRC/APW02623/323308/2015/139411, dt. 31.05.2015 was issued to the institution for conducting B.Ed. Programme of two years duration with an annual intake of 50 seats (One basic unit of 50 students) from session 2015-16.
- And whereas, the matter was placed before the WRC in its 255th Meeting held on June 22-24, 2016 and the Committee decided to issue show cause notice dt.09.09.2016.
- 5. And whereas, reply dt. 16.09.2016 was placed before the WRC in its 293thmeeting held on June 12–14, 2018 and the Committee decided as follows:-

"The case file was seen. Consequent to the issue of Revised Recognition order, Show Cause Notice dated 09.09.2016 was issued and the institute replied on 16.09.2016.

The institute has not submitted staff profile approved by the Registrar, Building Completion Certificate signed by a Govt. Engineer and FDRs for 12 Lakhs.

Hence, Recognition is withdrawn from the session 2018-19.

FDRs, if any, be returned."

- And whereas, a withdrawal Order No. WRC/APW02623/323308/Guj./293rd/2018/198649-198656 dt. 22.06.2018 was issued to the institution.
- 7. And whereas, the institution has filed an appeal at NCTE Hqrs. New Delhi and the Appellant Authority vide order dt. 12.09.2018 has decided as follows:-

"After perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that matter deserved to be remanded to the W.R.C for revisiting the matter, after the appellant institution submits required documents and taking further action expeditiously.

The council hereby remands back the case of I.D Patel College of Education, Vishwash City, Gathlodia, R.C. Technical Road, Ahmedabad Corporation, Gujarat to the WRC, NCTE, for necessary action as indicated above."

 And whereas, reply dt. 20.09.2018 of institution was placed before the WRC in its 299" meeting held on October, 30 - November 1, 2018, and Committee decided as follows:-

"This is a case of Appeal. The Appellate Authority vide order dated 12.09.2018 has remanded the case to WRC for revisiting the matter, after the appellant institution submits required documents and taking further action. On perusal of the reply dated 20.09.2018 submitted by the institution, the Committee observed that:-

(i) The institution has submitted the approved staff list of 1+11 faculty members.

(ii) Building Completion Certificate duly signed by competent authority submitted

(iii) FDR for Rs.12.00 lakhs as required under clause 10(1) of NCTE Regulations, 2014 submitted.

Hence, the Committee decided that Recognition of the institution be restored for one unit of B.Ed. course."

- Now therefore, this restoration order is issued as per decision of the WRC in its 299th meeting as cited above.
- Contravention of any of the provisions of the NCTE Act, 1993, NCTE Regulations, 2014 and any deviation from it will be liable for action, against the institution, as defined under NCTE Act, 1993 and NCTE Regulations, 2014.
